OLDEST BANK IN KENTUCKY

BANK OF MAYSVILLE

In 1835, the present **Bank of Maysville** opened for business in Maysville, Kentucky, as a branch of the Bank of Kentucky, whose main office was in Louisville, Kentucky. In 1871, when branch banking was prohibited by law in Kentucky, the organization was revamped and the name changed to the **Bank of Maysville**. In 1916, it absorbed the Union Trust Company of Maysville and joined the National Banking system using the name **Bank of Maysville**, National Banking Association.

Later, the **Bank of Maysville** consolidated under the laws of the Commonwealth of Kentucky with the First-Standard Bank and Trust Company and became a combined Bank and Trust Company, again assuming the name **Bank of Maysville**.

The first deposit received by the Bank was on June 26, 1835. In the early days of its existence, it issued currency, but discontinued doing so many years ago; yet occasionally a piece still turns up for redemption.

In the early days, banking was in no way similar to banking of today. Many of the deposits were "special deposits" consisting of packages of gold, silver, currency, etc. left with the bank and later called for by their owners.

During the Civil War, Colonel Pete Everett of Morgan's brigade of the Southern Confederacy made a raiding visit to Maysville, which necessitated the closing of the Bank. Under guard, all of the cash and securities were loaded into a wagon and moved to Hillsboro, Ohio where it was kept until the Colonel left town. Only then was it safely returned. On display in the bank is a gun belonging to Colonel Everett

The bank has been open for business every day since its establishment in 1835, expect Sundays, legally declared holidays, the Franklin Roosevelt Bank holiday, and Colonel Pete Everett's visit.

The **Bank of Maysville** has never failed to pay, upon presentation and in legal tender money, a check drawn against it by a depositor having the money to his credit. It weathered the dark days of 1933 with its own resources and without the sale of any preferred stock to the Government, and without borrowing any money from the Government or any other source.

In 165 years the bank has had only seven presidents. James A. Finch followed his father, J. M. Finch, Jr, and his grandfather, J. M. Finch, as third-generation President; thus a member of the Finch family has held that position since 1945. It has been doing business in its present location for eighty plus years and presently operates five branches.

The **Bank of Maysville** has contributed significantly to the agricultural, economic, educational, and social development of Mason County and is proud of its service to the citizens of Mason and surrounding counties. Many of the employees, like M. B. Denham, Jr, Executive Vice President and Cashier, with 27 years at the bank, have worked their entire career at the bank. The DFI is pleased to profile the oldest bank in Kentucky, the **Bank of Maysville**, in its 87th Annual Report.

FORMATION OF REGULATORY AGENCY

DEPARTMENT OF FINANCIAL INSTITUTIONS

he Department of Financial Institutions was established by the Banking Act of 1912 as the Department of Banking. It was charged "with the enforcement of all laws heretofore passed, or which may be passed, relating to banks, trust companies, savings banks, combined bank and trust companies, organized and doing business under the laws of the Commonwealth of Kentucky." (Chapter 4, Section 1, Acts of the General Assembly of 1912.)

Within a few years, however, other regulatory responsibilities were added as the state's economy and its financial services needs evolved.

The legislature mandated supervision of state-chartered savings [*building*] and loan associations to the department in 1918 and added state-chartered credit unions in 1922. When oversight of the state's securities industry was given to the department in mid-1932, the agency was renamed the *Department of Banking and Securities*.

Consumer and industrial loan companies were added to the list of agency-regulated industries in 1946. With passage of the Sale of Checks Act of 1966, the legislature also required companies that sell money orders to become licensed through the department.

The department's scope was expanded to include mortgage loan companies and mortgage loan brokers in 1980.

The department experienced a number of changes as a result of the 1984 General Assembly, which re-codified the Credit Union Act, overhauled the state's banking laws, changed the agency's name to the *Department of Financial Institutions* and established the *Financial Institutions Board*.

The Board is an advisory body comprised of 11 representatives from the respective financial services industries and the general public along with the Commissioner who serves as its chairman.

Through the Check Cashing Services Act of 1992, the legislature gave the department the responsibility for licensing check cashing (a/k/a deferred deposit) companies. The department assumed additional regulatory authority in 1998 when field examiners were assigned to conduct on-site inspections of these entities.

ORGANIZATION:

The **Commissioner** is the chief executive of the department and is responsible for implementing departmental policies, statutory mandates, and administrative regulations as well as for supervising the agency's day-to-day operations. The **Office of the Commissioner** also includes the **Office of General Counsel**, which handles the agency's legal affairs.

Ella D. Robinson, who had served as the agency's Deputy Commissioner for several years, assumed leadership of the department in December 1999 when Governor Paul Patton appointed her as its thirty-third Commissioner. In addition to the Office of the Commissioner and General Counsel, the Department is organized along functional lines into three divisions: *Financial Institutions*, *Securities*, and *Administrative Services*.

- C The Division of Financial Institutions is organized into three, industry-specific branches: Banks, Credit Unions, and Compliance and is responsible for chartering and/or licensing, examining, and otherwise supervising the operations of state-regulated depository and non-depository financial institutions.
- Similarly, the Division of Securities is organized into four branches: Corporations Finance, Compliance, Enforcement, and Licensing which handle the regulation and supervision of the state's securities industry by registering, licensing, examining, investigating, and otherwise supervising securities offerings, as well as securities firms and professionals operating in Kentucky and/or involving Kentucky investors.
- The Division of Administrative Services is organized into two branches: Administrative Services and Technology. As their names suggest, these branches are responsible for providing administrative (fiscal, training, operational, etc.) and technical (information systems) support services to the entire staff. The Administrative Services Branch is also responsible for layout and design of agency publications and assists in coordinating and supporting the agency's participation in trade shows, job/career fairs, town meetings, forums, and other media events.

The Department of Financial Institutions is one of 11 agencies within the Cabinet for Public Protection and Regulation and is totally self-funded. Revenues are derived from fees charged for assessments, examinations, call reports, applications, investigations, registrations, and licensing of state-chartered or licensed financial institutions and securities offerings and entities.

LEGISLATION AND REGULATION

During 1999 the Department continued its efforts to revise and modernize the laws and regulations relating to financial institutions. Obviously much of that effort involved preparing for the 2000 Session of the General Assembly. The Department worked on significant draft legislation, particularly relating to banks, consumer loan companies, check cashers, credit unions, and mortgage loan companies and mortgage loan brokers.

Regulatory initiatives were effective in 1999. The Division of Securities promulgated a new regulation, **808 KAR 10:400**. This new regulation established the fees to be charged for examinations of broker-dealers and investment advisors. The regulation also allows the Department to apply SEC and NASD rules when conducting examinations of regulated entities and individuals.

808 KAR 10:260 was amended to provide that investment advisers or investment adviser representatives who advise the public regarding securities shall demonstrate competence in the law of securities by providing the commissioner with proof of passing one or more of the examinations administered by the National Association of Securities Dealers. The regulation exempts individuals holding certain professional designations from the examination requirement. This amendment was necessitated by revisions to the content of the exams. The amendment is similar to regulatory provisions exacted in most of the fifty states during 1999.

DIVISION OF ADMINISTRATIVE SERVICES

he Division of Administrative Services is headed by a division director and is comprised of two branches: Administrative Services and Technology. Employees in this division work closely with the Commissioner and her staff to provide administrative and technological (information systems) support to all department staff and to manage the agency's public information and media relations endeavors.

In March 1999, the Department moved its Central/Frankfort Offices into new quarters – a major task that required the cooperative efforts of all Central Office employees, especially those in the Administrative Services Division who facilitated the move from conception to completion. The new offices, located at 1025 Capital Center Drive, offer a number of improvements designed to help staff work more effectively and efficiently to reach the Department's goals as well as their own.

ADMINISTRATIVE SERVICES BRANCH

Employees in the Administrative Services Branch provide administrative support to the department in the following areas:

- Facilities management: Frankfort office and district offices in Eddyville, Bowling Green, Louisville, and Lexington;
- Fiscal management;
- Operations and quality control;
- Records management;
- Agency publications; and
- Staff development: coordinating Employee Training & Continuing Education and Examiner Certification programs.

Most, if not all, Department employees attended at least one job-specific training event as required by agency policy. With 117 attendees in 70 different "training events," obviously some employees participated in more than one. A qualifying training event may be a one-day computer class or it may be a threeweek examiner school, but as the following table illustrates, 1999 was a productive year in terms of staff development through continuing education and training.

In mid-1999, the consumer complaints processing functions of the Public Affairs Branch were moved to the Office of the Commissioner and the Administrative Services Branch assumed the public information functions.

The Administrative Services Branch coordinates and supports the agency's efforts to inform/educate consumers, legislators, and industry representatives. During 1999, the Department participated in a number of public education forums, town meetings, and industry association meetings and increased its publication of educational and informational materials such as brochures, bulletins, and newsletters aimed at specific consumer and industry groups. In 1999 the Department expanded its mailing list and, through the Administrative Services Branch, sent copies of its 1998 Annual Report to all public libraries and to many senior citizens centers across the Commonwealth.

The Department also maintains a toll-free telephone number, and consumers and industry representatives wanting to speak with a member of the agency's staff are encouraged to call 1-800-223-2579 with their questions and concerns. Office hours are from 8:00 a.m. to 4:30 p.m. Eastern time.

DIVISION OF ADMINISTRATIVE SERVICES

TECHNOLOGY BRANCH

The Department of Financial Institutions (DFI), as a regulatory agency, investigates, examines, licenses, and monitors regulated financial industries doing business in the Commonwealth of Kentucky. DFI continues to work cooperatively with other agencies within state government and regulated financial industries outside state government to improve the delivery of DFI services by addressing business problems and opportunities through the effective use of Information Technology (IT).

The Department felt confident that Kentucky's financial service industries were preparing adequately for the Year 2000; however, DFI management also sought to ensure that its own systems were Y2K compliant while making its resources available to the financial community if they were needed. Therefore, in preparation for the impending millennial event and for possible man-made or natural disasters or emergencies, the Department's management team worked with Technology Branch employees to develop a Business Continuity Plan (BCP). The Plan's overall goal was "to articulate the minimum acceptable levels of quintessential service the



department is to provide in the event of a natural or technical failure or disaster and how those levels of service will be attained and maintained...[and]...to continue business operations while the failure(s) is being responded to." (Introduction, Business **Continuity Planning** Page Business Services Matrix, p.2, June 1999.) In the months leading up to January 1, 2000, new Information Technology staff moved quickly to bring the agency's entire processing

environment into complete compliance with the Governor's Y2K initiatives and make a smooth transition into the new millennium. Although most state government offices were "closed" from 12/31/99-1/4/00, selected crews of employees manned the Department's central and field offices during the New Year rollover weekend to ensure that critical mechanical, technical, and communications systems were working and to provide assistance to financial institutions and/or consumers if necessary.

1999 also saw the Department launch multiple planned activities designed to upgrade and enhance the Information Technology utilized at DFI. The upgrades and enhancements included as part of this new IT initiative are designed to track more completely DFI Management Information and to simplify access to DFI documents. This applies to DFI internal information repositories as well as to information needed by the financial community at large.

The growth of the Department's computing needs required an upgrade to the existing network infrastructure. Internal IT staff continue to monitor and maintain, as well as to provide, necessary computer resources to the DFI Field Offices. Plans are also underway to upgrade the Department's Internet and Intranet components to provide a more secure access to the agency's information repositories.

This re-engineering of DFI's business systems will save budget dollars over the long term by improving the workflow within and across the agency's divisions. The provision of a more complete integrated Management Information System and the opportunity to use the new system as a planning and management tool for the DFI management team, will provide an additional benefit of the new system.

Report of the Division of Securites An Overview of 1999 Initiatives

The staff members of the Division of Securities perform the various functions set forth below in carrying out the Department of Financial Institution's responsibility to administer the Securities Act of Kentucky. Each of these activities are intended to provide protection to the citizens of the Commonwealth by helping to ensure that securities transactions are effected in compliance with the Securities Act and that investors have thorough and accurate information available to them when they are evaluating an investment in a security or contemplating doing business with a securities professional.

Licensing – Licensing staff assist in the registration of, or determination to deny registration to, brokerdealers, investment advisers, and their employees. Another service provided by Licensing staff is to provide information to the public concerning a broker's disciplinary history.



- Compliance Examiners in the Compliance Branch perform routine (but often unannounced) examinations of broker-dealers, investment advisers, and their employees in the Commonwealth, in order to determine that they are complying with the investor protection laws.
- Enforcement Investigators in the Enforcement Branch investigate complaints filed with the Division by Kentucky citizens alleging securities fraud or other illegal conduct. In coordination with Department Legal staff, the investigators also assist in the administrative actions the Department takes from time to time against alleged violators of the Blue Sky Law.
- Corporations Finance Corporations Finance staff assist in the registration or exemption from registration of entities that issue securities in the Commonwealth. The staff in this branch also processes notice filings by issuers of federally covered securities such as mutual funds. The Corporations Finance staff also answer questions from the general public about the requirements for offerings of securities in Kentucky.

As can be observed in the charts included in this Report, the booming economy has kept the Division busy with steady increases in the numbers of firms and individuals registered with the Division and the high volume of notice filings by issuers of federally covered securities. Unfortunately for the public, the Division, like other securities regulators across the country, has also seen a dramatic increase over the past several years in the number of investigations performed by its Enforcement Branch. A number of these investigations involve allegations of fraudulent conduct that is believed to have caused substantial losses to individual investors in the Commonwealth. Through regulatory efforts and investor education initiatives, the Division can only hope to stem the tide on this disturbing trend.
